

Early", prepared by J.D. Calmes, Reg. Surveyor, dated August 18, 1956 and recorded in the RMC Office for Greenville County in Plat Book FF at Page 461 and has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Sunrise Drive at the intersection of said drive with an unnamed drive; thence along the northerly side of Sunrise Drive, S. 58-40 E. 78.9 feet to an old iron pin; thence N. 32-26 E. 119.5 feet to an iron pin; thence N. 71-26 W. 96.11 feet to an iron pin on the easterly side of unramed drive; thence along said drive, S. 23-59 W. 99.4 feet to an iron pin, the same being identified on above mentioned plat as Cottage No. 3.
