All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 104 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March, 1960, and recorded in the R.M.C. Office for Greenville County in Plat Book QQ, at page 6, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of Ridge Spring Stret, joint front corner of Lots 100 and 104, and running thence along the joint line of said lots, S. 4-24 s. 175 feet to an iron pin on the rear line of Lot No. 119; thence along the line of that lot, N. 85-36 s. 49 feet to an iron pin, the joint rear corner of Lots 119 and 118; thence along the rear line of Lot 118, S. 85-45 s. 41.1 feet to an iron pin at the rear corner of Lot 105; thence along the line of that lot, N. 4-24 W. 181.2 feet to an iron pin on the southern edge of Ridge Spring Street; thence along the southern edge of Ridge Spring Street; to an iron pin, the beginedge of Ridge Spring Street, S. 85-36 W. 90 feet to an iron pin, the beginning corner; being a portion of the property conveyed to Greenville Land Co., Inc. by Richard F.
