the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto Wooten Corporation of Wilmington, its Successors and Assigns,

All that certain piece, parcel, or lot of land with any improvements thereon, situate, lying, and being on the western side of West Castle Road in Pine Hill Village, Gantt Township, Greenville County, South Carolina, which is the major portion of Lot 178; which on a plat of Pine Hill Village, prepared by R. K. Campbell, R.L.S., dated July 9, 1962, and recorded in the Office of the R.M.C. for said County and State in Plat Book "QQ", Page 168, and which major portion of Lot 178 is more particularly described as follows:

BEGINNING at an iron pin on the western side of said Road, joint front corner of Lots 177 and 178, and running thence N. 66-14 W. 130 feet along the joint line of said lots to an iron pin, joint rear corner of said lots; thence S. 23-46 W. 67 feet to an iron pin, joint rear corner of Lots 178 and 179; thence S. 66-14 E. 133.1 feet along the joint line of said lots to an iron pin on the western side of said Road, joint front corner of said lots; thence along the western side of said Road on a curve, the chord of which is N. 18-49 E., 35.2 feet to an iron pin; thence N. 23-46 E. 32 feet still along the western side of said Road to an iron pin, the point of beginning.
