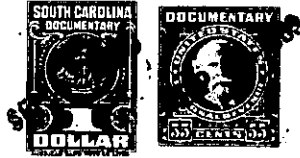

All that piece, parcel or lot of land situate, lying and being in the City and County of Greenville, State of South Carolina, on the eastern side of Sitka Avenue and being known and designated as Lot No. 25 of Parkview as shown on plat thereof recorded in the R. M. C. Office for Greenville County in Plat Book "M", at Page 49 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Sitka Avenue at the joint front corner of Lots Nos. 25 and 26 and running thence along said Avenue N. 26-15 W. 50 feet to an iron pin; thence along the line of Lot No. 24 N. 63-45 E. 150 feet to an iron pin; thence S. 26-15 E. 50 feet to an iron pin; thence along the line of Lot No. 26 S. 63-45 W. 150 feet to the point of beginning.
