in consideration of Ten and No/100 (\$10.00) and other valuable considerations and assumption of mortgage set out below Dollars,  
the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Charles L. Edens and Doris P. Edens, their heirs and assigns forever:

All that lot of land, with the buildings and improvements thereon, situate on the southeast side of Ashford Avenue, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 80 on plat of Vista Hills, made by Dalton & Neves, Engineers, May 1946, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book P, at page 149, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeast side of Ashford Avenue, at joint front corner of Lots 79 and 80, and running thence with the line of Lot 79, S. 34-14 W. 160 feet to an iron pin; thence N. 55-46 E. 70 feet to an iron pin; thence with the line of Lot 81, N. 34-14 W. 160 feet to an iron pin on the southeast side of Ashford Avenue; thence with the southeast side of Ashford Avenue, S. 55-46 W. 70 feet to the beginning corner; being the same conveyed to us by Stephen A. Backiel by deed dated February 18, 1956 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 545 at Page 538.

As a part of the consideration for this conveyance, the grantees expressly assume and agree to pay the balance due on that certain note and mortgage, in the original sum of \$12,700.00 executed by the grantors to The Prudential Insurance Company of America and recorded in the R. M. C. Office for Greenville County in Mortgage Book 669 at Page 183, the balance due thereon being the sum of \$ 10,244.88 as of this date.
