the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto ROBERT C. GRIER, JR., his heirs and assigns,

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Sixty-Nine (69) of Section One of Chanticleer, as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the RMC Office for Greenville County in Plat Book YY at page 97; and having; according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the western side of West Seven Oaks Drive at the joint front corner of Lots 68 and 69 and running thence with the western side of West Seven Oaks Drive S. 1 - 29 W. 25.2 feet to an iron pin; thence still with the western side of West Seven Oaks Drive S. 13 - 08 E. 75.8 feet to an iron pin at the joint front corner of Lots 69 and 70; thence with the line of Lot 70 S. 66 - 03 W. 247.9 feet to an iron pin on the line of the property formerly belonging to the Estate of M. D. Earle; thence with the M. D. Earle line N. 52 - 12 W. 87.1 to an iron pin on the line of property of F. H. Earle; thence with the line of property of F. H. Earle N. 23 - 48 E. 167.8 feet to an iron pin at the joint rear corner of Lots 68 and 69; thence with the line of Lot 68 N. 88 - 01 W. 211.2 feet to the beginning corner.
