ALL that certain piece, parcel or tract of land in Paris Mountain Township, Greenville County, State of South Carolina, situate in the fork of Farrs Bridge Road and White Horse Road, being a portion of Tract No. 6 of the M. J. Huff Estate and having, according to survey by J. C. Hill, Surveyor, dated October 1, 1963, the following metes and bounds, to-wit:
