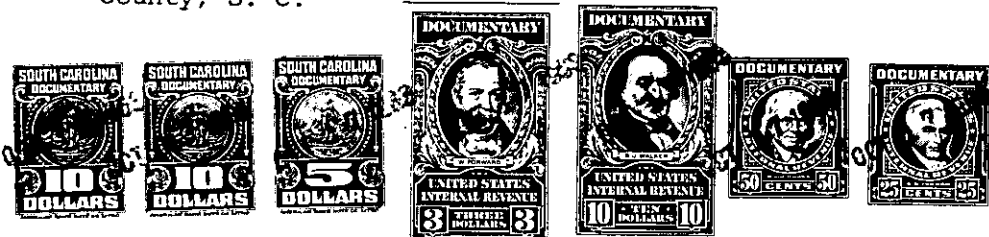

All that lot of land in the county of Greenville, state of South Carolina, being known and designated as Lot No. 5 on plat of Addition to Highview Acres recorded in plat book GG page 122 of the RMC Office for Greenville County, S.C. and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the north side of Arlene Drive, the joint front corner of Lots Nos. 5 & 6; thence with the joint line of said lots N. 5-30 E. 175 feet to an iron pin; thence S. 84-30 E. 90 feet to an iron pin corner of Lot No. 4; thence with the line of said lot S. 5-30 W. 175 feet to an iron pin on the north side of Arlene Drive; thence with the north side of said street N. 84-30 W. 90 feet to the beginning corner.
