in consideration of the sum of Twelve Hundred Fifty and no/100 (\$1250.00) - - - - - DOLLARS,

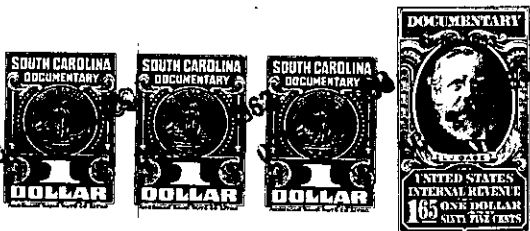
