BROWNSTEIN, of Washington, D.C., as Federal Housing Commissioner, Grantor, for and in consideration of the sum of ONE DOLLAR (\$1.00) and other valuable considerations, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto THOMAS P. CALDWELL

Grantee(s), and to the heirs and assigns of said Grantee(s),

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the westerly side of Fairmont Avenue, near the City of Greenville, S.C., being known and designated as Lot No. 31, as shown on plat of portion of Extension of Brookforest, as recorded in the RMC Office for Greenville County, S.C. in Plat Book 00, page 334, and having according to said plat the following metes and bounds, to-wit: Beginning at an iron pin on the westerly side of Fairmont Avenue, said pin being the joint front corner of Lots 31 and 32, and running thence with the common line of said Lots S-84-28 W 135.5 feet to an iron pin, joint rear corner of Lots 31 and 32; thence S 5-32 E 80 feet to an iron pin; thence N 84-28 E 135.5 feet to an iron pin on the westerly side of Fairmont Avenue; thence with the westerly side of Fairmont Avenue N 5-32 W 80 feet to an iron pin, the point of beginning.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise appertaining or incident.

TO HAVE AND TO HOLD all and singular the premises before mentioned, unto the said Grantee(s), and to the heirs and assigns of said Grantee(s) forever.

SUBJECT to all covenants, restrictions, reservations, easements, conditions and rights appearing of record; and SUBJECT to any state of facts an accurate survey would show.

AND THE SAID GRANTOR covenants that he has not made, done, committed, executed or suffered any act or acts, thing or things whatsoever, whereby or by means whereof, the above mentioned and described premises, or any part or parcel thereof, now are, or at any time hereafter shall or may be impeached, charged or encumbered in any manner or way whatsoever.
