Painter and Jerry Painter, their heirs and assigns forever:

All that lot of land in Cleveland Township, Greenville County, State of South Carolina, being known and designated as Lot No. 30 of Section Two of Silver Shoals, recorded in the R. M. C. Office for Greenville County in Plat Book MM at Page 35, and described as follows:

BEGINNING at an iron pin on the Southeastern side of Shoals Drive at the corner of Lot No. 31 and running thence with the Southeastern side of Shoals Drive, N. 56-00 E. 80 feet to the corner of Lot No. 29; thence with the line of Lot No. 29, S 26-05 E. 181.1 feet to an iron pin; thence S. 56-44 W. 80 feet to an iron pin at the corner of Lot No. 31; thence with the line of said lot, N. 25-50 W. 180.0 feet to the beginning corner.

It is understood that this lot is conveyed subject to the building code of Silver Shoals and shall become a part of the water district of Silver Shoals.

It is understood that the grantees shall have access and privilege of the use of the Middle Saluda River, together with the other property owners purchasing other lots from the grantor, with the exception of the river front area immediately in front of Lot 33 and west therefrom which is expressly reserved to the grantor.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

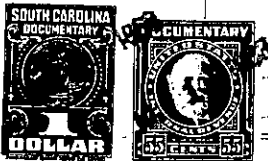
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.
