- (d) One lot on which is erected Grantor's two-story office building at 310 Main Street, Belton, South Carolina, described as follows: All that certain lot or parcel of land in the Town of Belton, in Anderson County, South Carolina, on the east side of the public square and fronting thereon for 31 feet 8 inches, more or less, and extending back eastwardly 110.5 feet, more or less, to a 15-foot alley, this being the major portion of the parcel of land conveyed to Belton Light and Power Company by deed of Moffatt T. H. Shearer, Surveyor, dated May 13, 1937, and recorded in said office in Plat Book 13, at page 34. This is all of the property conveyed to Belton Light and Power Company by deed of Belton Mills dated July 7, 1937, and recorded in said office in Deed Book 6-Q, at page 747, and the major portion of the lot conveyed to said Company by deed of Ralph F. King, Probate Judge as Special Referee, dated June 15, 1937, and recorded therein in Deed Book 6-Q, at page 711. From said lot a well lot 6 ft. by 7 ft. in size has been conveyed to the Town of Belton, together with rights of ingress and egress thereto as shown by deed recorded in said office in Deed Book 9-B, at page 43.

In Greenville and Anderson Counties, South Carolina:
