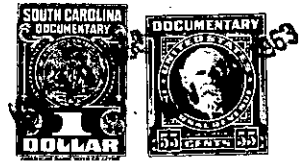

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Bill Earle, his heirs and assigns,

All that certain piece, parcel or tract of land situate, lying and being in Greenville County, Grove Township and containing one (1) acre, according to plat of the property of Elijah Hawthorne made by Caroline Engineering & Surveying Co., November 11, 1963, and according to said plat being more particularly described as follows:

BEGINNING At an B. C. in the center of Neeley Ferry Road and running along a County Road S. 38-0 W. 210 feet to an iron pin; thence S. 55-45 E. 210 feet to an iron pin on property of Elijah Hawthorne; thence continuing along said property, N. 38-0 E. 210 feet to a spike in the center of Neeley Ferry Road; thence along the center of Neeley Ferry Road, N. 55-45 W. 210 feet to a B. C., the beginning corner, and being a portion of the property conveyed to the grantor herein by Mattie G. Andrews by deed recorded in the R. M. C. Office for Greenville County in deed volume 109 at page 167.
