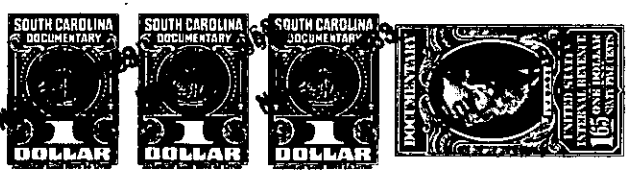
KNOW ALL MEN BY THESE PRESENTS, that I, Florrie E. Greer

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Jack C. Durham and Mary D. Durham, their heirs and assigns forever:

All that certain piece, parcel or lot of land, lying and being situate in Austin Township, Greenville County, State of South Carolina, being known and designated as Lot No. 6, Block B as shown on a plat of property of Mrs. B. E Greer and known as West Golden Strip Drive, plat of said subdivision being recorded in the Greenville County R. M. C. Office, and being more fully described as follows:

BEGINNING at an iron pin on the North West side of West Golden Strip Drive, joint corner with lot No. 5, and running thence along line of lot No. 5, N. 30-00 W. 265.2 feet to an iron pin; thence N. 48-30 E. 102 feet to an iron pin; thence along line of lot No. 7, S. 30-00 E. 285.5 feet to an iron pin on West Golden Strip Drive; thence along said Drive S. 60-00 W. 100 ft. to the beginning corner, and being a portion of the same property conveyed to B. E. Greer by Ola Harbin by deed recorded in Deed Book 289 at page 319 in the Greenville County R. M. C. Office, and this conveyance is here made in accordance with the terms of the will of the said B. E. Greer, deceased, said will being on file in file 633, Apt. 38 in the Office of the Probate Judge for Greenville County.

In making this conveyance, the Grantor herein reserves a 5 foot drainage easement across said lot at approximately 80 feet from rear line.
