Know All Men by These Presents:

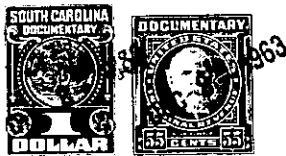
That I, J.T. Collins, Trustee for J.T. Collins and W.M. Batson, Jr.
