Baker, Jr., his heirs and assigns, forever:

all that certain piece, parcel or lot of land situate, lying and being in Bates Township, Greenville County, State of South Carolina, in the town of Marietta, on the N/S of Slater Road, being shown as Lot no. three (3) on a plat of survey of the property of Jessie S. Baker, made by T. T. Dill, surveyor, January 26, 1961, and having, according to said plat, the following metes and bounds, to-wit:
