

ALL that piece, parcel or lot of land in the State and County aforesaid, being known and designated as Lot No. 66, as shown on a plat of Pinewood Estates by H. S. Brockman, Surveyor, dated November 1958 and recorded in the R. M. C. Office for Greenville County in Plat Book, MM, at Page 55, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron on Christie Drive, joint front corners of Lots Nos. 65 and 66 and running thence along the line of said lots, S. 88-05 W. 170 feet to iron pin rear line of Lot 64; thence running with rear lines of Lots 64 and 63, S. 1-55 E. 90 feet to iron pin rear corner of Lot 67; thence running with line of said lot, N. 88-05 E. 170 feet to iron pin on Christie Drive; thence running with Christie Drive, N. 1-55 W. 90 feet to iron pin point of beginning.
