ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Harvley Street in the City of Greenville and being known as Lot 18 on plat of Property of W. M. Jordon, et al, made by R. E. Dalton, Engineer, March 1921, and recorded in the R. M. C. Office for Greenville County in Plat Book E at Page 214 and having according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Harvley Street at the joint corner of Lots 18 and 19, said pin being approximately 430 feet east from the southeast corner of the intersection of Harvley Street and Rutherford Street and running thence with the line of Lot 19, S. 1-56 W. 138.8 feet to an iron pin on the north side of Bull's Alley; thence with the north side of Bull's Alley, S. 87-43 E. 50 feet to an iron pin at the corner of Lot 17, thence with the line of Lot 17, N. 1-56 E. 139.1 feet to an iron pin on the south side of Harvley Street; thence along the south side of Harvley Street, N. 88-04 W. 50 feet to the beginning corner; being the same property conveyed to Catherine V.
