That I, R. D. Wilson

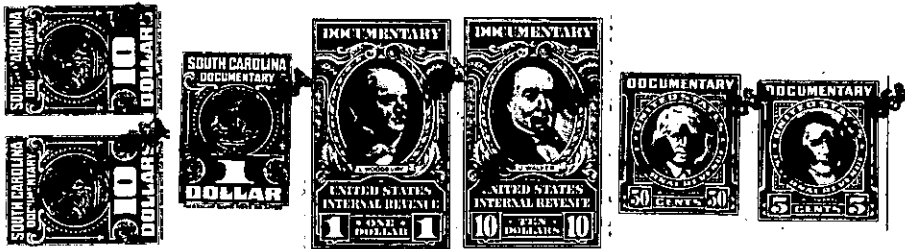
in consideration of the sum of Ten Thousand Five Hundred and no/100 (\$10,500.00) - DOLLARS,
