1. KNOW ALL MEN BY THESE PRESENTS: That Botany Woods, Inc.
andgrantor(s), in consideration of \$190.00 , paid by Wade Hampton Water & Sewer District Commission, a body politic under the laws of South Carolina, hereinafter called the Grantee, receipt of which is hereby acknowledged, do hereby grant and convey unto the said grantee a right of way in and over my (our) tract(s) of land situate in the above State and County and deed to which is
recorded in the office of the R. M. C., of said State and County in Book 669 at page 11 and Book
at page, said lands being known and designated as Lot P. 15.13-
1-268, Map Book, Greenville County (Lot 308 Sec VII)
and encroaching on my (our) land a distance of 191 feet, more or less, and being that portion of my
(our) said land 25 feet wide, extending 12 1/2 feet on each side of the center line as same has been marked out on the ground, and being shown on a print on file in the offices of Wade Hampton Water & Sewer District Commission. The Grantor(s) herein by these presents warrants that there are no liens, mortgages, or other encumbrances to a
clear title to these lands, except as follows: James L. Love & W. W. Wilkins, as Trustees, Mtge. Vol. 850, page 552 and Sloan Construction Company, assigned to C & S National Bank,
which is recorded in the office of the R. M. C., of the above said State and County in Mortgage Book 901 at page
and that they ## (are) legally qualified and entitled to grant a right of way with respect to the
lands described herein. The expression or designation "Grantor" wherever used herein shall be understood to include the Mortgagee, if any there be.
 The right of way is to and does convey to the grantee, its successors and assigns the following: The right and privilege of entering the aforesaid strip of land, and to construct, maintain and operate within the limits of same, pipe lines, manholes, and any other adjuncts deemed by the grantee to be necessary for the purpose of conveying sanitary sewage and industrial wastes, and to make such relocations, changes, renewals, substitutions, replacements and additions of or to the same from time to time as said grantee may deem desirable; the right at all times to cut away and keep clear of said pipe lines any and all vegetation that might, in the opinion of the grantee, endanger or injure the pipe lines or their appurtenances, or interfere with their proper operation or maintenance; the right of ingress to and egress from said strip of land across the land referred to above for the purpose of exercising the rights herein granted; provided that the failure of the grantee to exercise any of the rights herein granted shall not be construed as a waiver or abandonment of the right thereafter at any time and from time to time to exercise any or all of same. No building shall be erected over said sewer pipe line nor so close thereto as to impose any load thereon. 3.
