Know All Men by These Presents:

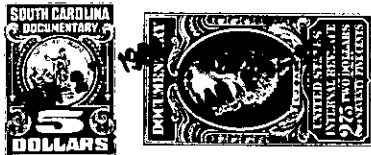

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, and being shown as Lot No. 17 on a plat of the property of C. W. Wood, recorded in the RMC Office for Greenville County in Plat Book UU, Page 80 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Eunice Drive at the joint front corner of Lots 16 & 17 and running thence with the common line of said lots S. 88-47 E. 174 feet, more or less, to a point in the center of a branch; thence up the center of said branch, as the line, the traverse of which is N. 30-26 W. 303.8 feet to a point in the center of said branch on the southerly side of Eunice Drive; thence with said Drive S. 18-51 W. 102.4 feet to an iron pin; thence continuing with said Drive S. 2-53 W. 160 feet to the point of beginning.
