

All that lot of land with the buildings and improvements thereon, situate on the South side of Primrose Lane and on the Southwest side of Lullwater Road, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 62 on plat of Northside Gardens made by Dalton & Neves, Engineers, November 1946, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "S", Page 17, and having, according to said plat, the following metes and bounds,

BEGINNING at an iron pin on the Southwest side of Lullwater Road at joint front corner of Lots 61 and 62 and running thence with the line of Lot 61, S. 48-52 W., 200.2 feet to an iron pin; thence N. 41-19 W., 187.3 feet to an iron pin on the South side of Primrose Lane; thence with the South side of Primrose Lane, N. 80-45 E., 171.7 feet to an iron pin; thence with the curve of Primrose Lane and Lullwater Road (the chord being S. 70-02 E., 60 feet) to an iron pin on the Southwest side of Lullwater Road; thence with the curve of Lullwater Road (the chord being S. 71-45 E.; 51 feet) to the beginning corner.

Being the same property conveyed to the grantor herein by Judson F. Ayers, Jr., as Trustee in Bankruptcy for Sidney L. Schiro and Mac J. Cahn, individually and as co-partners t/a Fashionality Blouses, by deed recorded in the R. M. C. Office for Greenville County in Deed Book 741 at Page 170.
