BOLAND, HIS HEIRS AND ASSIGNS:

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, near the City of Greenville, and being known and designated as Lot Number 43 of the Property of Wm. R. Timmons, Jr., according to a plat of record in the R. M. C. Office for Greenville County in Plat Book MM at Page 127, and having the following metes and bounds, to wit:

BEGINNING at a point on the Western side of Penarth Street at the joint front corner of Lots 42 and 43 and running thence with the Western side of Penarth Street N 2-50 E 80 feet to a point at the joint front corner of Lots 43 and 44; thence S. 87-10 E. 175 feet to a point at the joint rear corner of Lots 43 and 44; thence S 2-50 W 80 feet to a point at the joint rear corner of Lots 42 and 43; thence N 87-10 W 175 feet to the point of beginning.
