Dr.E.P.Douglas, Grantee, and his heirs and assigns forever, All of those certain lots of land in said State and County, Glassy Mountain Township, lying about one mile West from Glassy Mountain Baptist Church, and about four miles North from Highland and about 800 feet North from Highway No.11 and being a small portion of the same tract of land conveyed to me by Henry (H.D.) Lindsey, my Husband, about thirty years ago and recorded in offise of R.M.C. for Greenville County, and being more particularly described as follows;
