ALL that lot of land situate on the Northeast side of White Horse Road (also known as S. C. Highway No. 250) near the City of Greenville, in Gantt Township, in Greenville County, S. C., being shown as a front portion of Lot 3 on plat of Property of Jack K. Wherry and C. L. Miller, made by Pickell & Pickell, Engineers, May 1957, recorded in the RMC Office for Greenville County, S. C., in Plat Book "KK", at page 109, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northeast side of White Horse Road, at joint front corner of Lots 2 and 3, and running theme along the line of Lot 2, N. 63-02 E., 200 feet to an iron pin; thence through Lot 3, approximately N. 25-43 W., 100 feet, more or less, to a point in the joint line of Lots 3 and 4; thence along the line of Lot 4, S. 65-07 W., 200 feet to an iron pin on the Northeast side of White Horse Road; the step beginning corner. 100 feet to the beginning corner.
