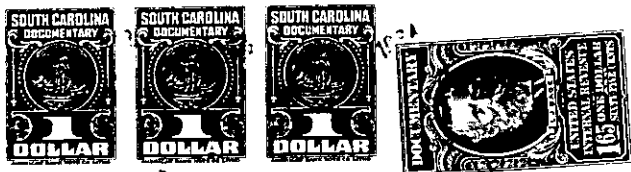

All that certain piece, parcel or lot of land, lying and being in Austin Township, Greenville County, State of South Carolina, being known and designated as lot No. 15, Block "A" in the subdivision of Mrs. B. E. Greer on West Golden Strip Drive, plat of said subdivision being recorded in the Greenville County R. M. C. Office and being more fully described as follows:

BEGINNING at an iron pin on the south side of West Golden Strip Drive, joint corner with lot No. 14, and running thence S. 30-00 E. 283.2 feet to an iron pin; thence N. 46-30 E. 180 feet to an iron pin on Western frontage road for Highway 276; thence along said frontage road N. 44-23 W. 254.2 feet to an iron pin at intersection of West Golden Strip Drive; thence along said drive S. 57-30 W. 111.8 feet to the beginning corner, and being a portion of the same property conveyed to B. E. Greer by Ola Harbin by deed recorded in Deed Book 289 at page 319 in the Greenville County R. M. C. Office, and this conveyance is here made by Florrie E.
