

All that certain piece, parcel or lot of land, with all improvements theron, situate, lying and being in the State of South Carolina, County of Greenville, at the Northeast corner of the intersection of Middleton Lane and Woodridge Circle, near the Town of Mauldin, being shown as Lot No. 52 on the plat of Windsor Park made by R.K. Campbell, Surveyor, March 29, 1960 recorded in the RMC Office of Greenville County, S.C. in Plat Book RR, page 25, and having, according to the said plat the following metes and bounds, to-wit: BEGINNING at an iron pin on the north side of Middleton Lane at the joint corner of Lots 52 and 58, and mns thence along the line of Lot 53, North 8-35 East 120.6 feet to an iron pin; thence with the line of Lot 65 North 71-0 West 120.6 feet to an iron pin on the East Side of Woodridge Circle; thence along Woodridge Circle South 19-0 West 105 feet to an iron pin; thence with the curve of Woodridge Circle and Middleton Lane (the chord being South 31-14 East 51.1 feet) to an iron pin on the North side of Middleton Lane; thence along Middleton Lane South 81-25 East 105 feet to the BEGINNING corner; this being the identical property conv eyed to W.E. Heath, Jr. and Sue E. Heath, by J.H. Mauldin by deed dated August 4, 1961, of record in Deed Volume 679, at page 367, in the RMC Office for Greenville, South Carolina"
