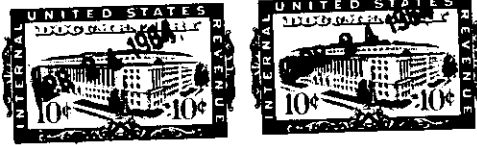

KNOW ALL MEN BY THESE PRESENTS, that We, R. M. CAINE AND ALFRED T. SMITH, AS TRUSTEES,

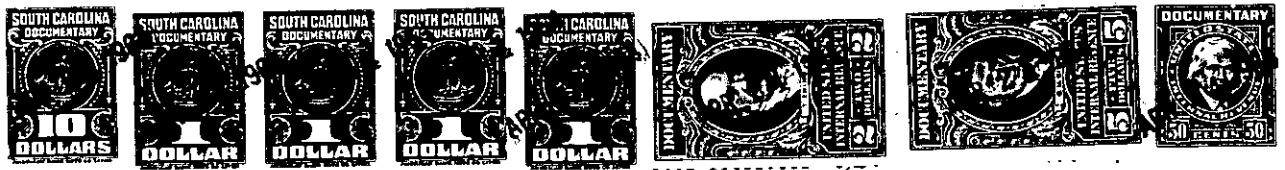
in consideration of Six Thousand Six Hundred and no/100 (\$6,600.00) ----- Dollars,
 the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto
 J. P. and SARA M. LOWRY, their heirs and assigns, forever:

All that lot of land in the City and County of Greenville, State of South Carolina, being shown as a portion of Tract 2 on Plat of Property of R. M. Caine, et al, recorded in Plat Book "XX" at page 39 and, having, according to a revised plat by Piedmont Engineering Service, October 1, 1962, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Earle Drive, which iron pin is approximately 88.8 feet North of the intersection of Wade Hampton Boulevard; running thence N. 18-22 W., 69.5 feet to an iron pin on the southeastern side of a 10-foot alley; thence along said alley, N. 52-43 E., 75.3 feet to an iron pin; thence along the property on which there is situate the Dobbs House, S. 37-34 E., 66 feet to an iron pin, which iron pin is situate N. 37-34 W., 84 feet from Wade Hampton Boulevard; thence along the service station on the corner, S. 52-43 W., 98.1 feet to the point of beginning and being a portion of the same property conveyed to us in Deed Book 693 at page 326.

The Grantees, their heirs and assigns, are hereby given the right, along with others, to use the 10-foot alley adjoining this property on the northern side. This easement is not exclusive in that the other adjoining property owners, shall likewise, be given the right to this alley. It shall remain a private alley, unless all the persons having a right thereto shall, at some subsequent date, desire to execute a document making it a public alley.
