All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 6 on a plat of Farmington Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Pages 106-7 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Claxton Drive at the joint front corner of Lots 5 & 6 and running thence with the common line of said lots S. 38-48 E. 200 feet to an iron pin; thence N. 51-12 E. 100 feet to an iron pin; thence N. 38-48 W. 200 feet to an iron pin on the southeasterly side of Claxton Drive; thence with said Drive S. 51-12 W. 100 feet to the point of beginning.
