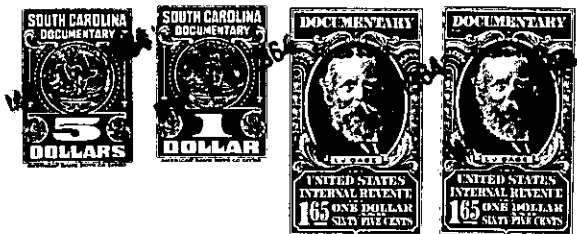
KNOW ALL MEN BY THESE PRESENTS, that M. E. Howell
