- 3. Hereby assign, transfer and set over to Bank, its successors and assigns, all monies now due and hereafter the undersigned, as rental, or otherwise, and howsoever for or on account of that certain real property situated

All that lot of land on the Southern side of Pacific Avenue in the City of Greenving being shown as Lot 374 on plat of Pleasant Valley recorded in Plat Book P at page 114 and described as follows:

- Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and the interpretation of the undersigned, their heirs, legatees, devisees, administrators, executors, successors and and inure to the benefit of Bank and its successors and assigns.
