ALL that certain piece, parcel or lot of land lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the North side of East North Street (also known as I-385) shown as lot entitled Inglesby on that plat entitled Property of Greenville Memorial Auditorium, dated April and May, 1964, made by Dalton & Neves, Engineers, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of East North Street (also known as I-385) said pin being 80 feet East from the Northeast corner of the intersection of East North Street and Thompson Street and runs thence N. 4-52 W., 200 feet to an iron pin; thence N. 78-00 E., 68.8 feet to an iron pin; thence S 9-25 E., 197.5 feet to an iron pin on the North side of East North Street; thence along the North side of East North Street, S. 76-35 W., 81.8 feet to the beginning corner.

C., as Executor and Trustee under said Will giving full power to sell and convey this property to the Executors and Trustees.
