S. Brockman, November 4, 1952, recorded in Plat Book "CC", page 167, and according to a recent survey prepared by J. C. Hill, May 16, 1953, is described as follows:

Said premises being the same property conveyed to the grantor by deed recorded in Deed Volume 519, page 530.
