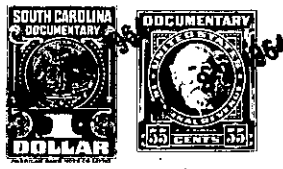

KNOW ALL MEN BY THESE PRESENTS, that I, M. W. Fore

in consideration of One Hundred Fifty & NO/100 (\$150.00) - - - - - Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

Dewey N. Johnson & Rachel J. Johnson, their heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situated just below the town of Piedmont, South Carolina, being known and designated as Lot No. 12, of a subdivision known as Monticello Estates, as shown by a plat thereof, by Woodward Engineering Company, dated March 1956, and recorded in the R. M. C. Office for Greenville County, in Plat Book EE, at Page 169, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on East Monticello Road, joint front corners of Lots 11 and 12 and running thence along the lines of said lots, S. 71-00 E. 160 feet to iron pin line of Lot 10; thence running with line of said lot, S. 19-00 W. 74 feet to iron pin rear corner of Lot 13; thence running with line of said lot, N. 71-00 W. 160 feet to iron pin on East Monticello Road; thence running with said road, N. 19-00 E. 74 feet to iron pin point of beginning.

NO residence to cost less than Five Thousand (\$5,000.00) Dollars shall be erected on any lot; no residence shall be erected on lots nearer than forty (40) feet to the front line; no outside toilets permitted and sewage to be disposed of by approved septic tanks.

THIS conveyance is subject to all easements and rights of way of record.

GRANTEE to pay 1964 taxes.
