BEGINNING at an iron pin on the Northern side of Ledford Drive at the joint front corner of Lots Nos. 5 and 6 and running thence with Lot No. 6 N. 2-50 E. 128.1 feet to an iron pin; thence N. 86-42 W. 100 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5; thence with the line of Lot No. 4 S. 1-15 E. 140 feet to an iron pin on the Northern side of Ledford Drive; thence with the Northern side of Ledford Drive and following the curve thereof, the chord of which is N. 81-45 E. 60 feet, to an iron pin; thence continuing with the Northern side of Ledford Drive S. 87-35 E. 31 feet to the point of beginning.



