in consideration of wenty five thousand two hundred sixty eight 90/100 - - -Dollars. the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release Wade $H_{\rm w}$ Denmis, his heirs and assigns

All that certain piece, parcel or lot of land in Greenville county, state of South C rolina, on the south side of E. North street in the city of Greenville, being Act number 5 and a portion of lot 6 Block 7, as shown on a plat of Boyce Lawn addition recorded in the n.M.C. office for Greenville county, 5... in Plat book "A" at page 179 and according to a survey made by J.C. Hill on June 27,1959, described as follows:

Beginning at an iron pin on the southern side of east North street 54 feet west from Carolina avenue, and running thence with the southern side of said street, S.76-45 w. 54 feet to corner of lot of Harold L. Dillard and James F. Finley; thence along joint side line with Dillard and Finley 126.1 feet to an iron pin on a 10 foot alley; thence with the northern side of said alley N.76-45 E. 54 feet to an iron pin; thence N. 15-0 W. 126.1 feet to the point of beginning. Less, however, the portion of said property acquired by the State highway Department for the widening of E. North street.

This deed is made subject to a contract with the said Harold L. Pillard and James F. Finley that provides for a joint driveway. Said contract is recorded in the R.M.C. office for Greenville County in deed book 724 at page 375, and grantor intends to convey to grantee herein all of his right, title, and interest in the said contract.

The herein named grantee agrees to pay the 1964 taxes on the abovedescribed property. The abovedescribed property is a part of the property conveyed by Urban and Rural Land Corporation to E. Mitchell Arnold and Ellison G. Webster, Jr., by deed dated April 2, 1962, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 695, Page 335. By deed dated April 2, 1962, recorded in the said R.M.C. Office in Deed Book 695, Page 362, E. Mitchell Arnold conveyed his undivided one-half interest in the property to Ellison G. Webster, Jr., the grantor herein.

The abovedescribed property is further identified on the City Block Book as Lot 2, Block 3, Page 47, in School District 500.
