unto James D. Stone, his heirs and assigns forever:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, being known and designated as Lot No. 18, as shown on a plat of Valencia Estates by W. N. Willis, Engineers, dated November 19, 1960, recorded in the R. M. C. Office for Greenville County in Plat Book MM, at Page 179, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Valencia Drive, joint front corners of Lots Nos. 17 and 18 and running thence along the lines of said lots, N. 4-32 E. 180 feet to iron pin; thence running with rear line of Lot 18, N. 85-28 W. 80 feet to iron pin rear corner of Lot 19; thence running with line of said lot, S. 4-32 W. 180 feet to iron pin on Valencia Drive; thence running with Valencia Drive, S. 85-28 E. 80 feet to iron pin point of beginning.

NO residence to cost less than \$10,000.00 shall be erected on any lot; no residence shall be erected on lots nearer than 35 feet to the front line; no residence shall be built on any lot unless said lot has 70 feet, or more, frontage; no outside toilets permitted and sewage to be disposed of by approved septic tanks; all lots to be used for residential purposes only.

THIS conveyance is subject to all easements and rights of way of record.
