Donaldson died testate in October, 1934, and by his Will which is on file in the Office of the Probate Judge for Greenville County in Apartment 550, File 3, devised his interest in the property herein, the same being an undivided one-third interest, to his wife, Elizabeth W. Donaldson, and his children, Mary Sue D. Rucker, Augustus H. Donaldson, and Thomas Q. Donaldson, Jr. The said Thomas Q. Donaldson, Jr. died testate in Pima County, Arizona, in 1955, and by his Will which is on file in the Office of the Probate Judge for Greenville County in Apartment 875, File / devised all his property to his wife, Elizabeth R. Donaldson, one of the grantors herein. The said Elizabeth W. Donaldson, the , devised all his wife of General Thomas Q. Donaldson, died testate in Hendersonville, North Carolina, on November 6, 1959, and by her Will which is on file in the Office of the Surrogate's Court for New York County, New York, devised all her property to her children, Mary Sue D. Rucker, one of the grantors herein, Augustus H. Donaldson, one of the grantors herein, and her daughter-in-law, Elizabeth R. Donaldson, one of the grantors herein.
