Taylor, for and during the term of their joint lives, and on the death of either to the survivor and to his or her heirs and assigns forever.

All that lot of land in Greenville County, State of South Carolina, on the western side of Balfer Drive, near the City of Greenville, and being shown as Lot 92 on plat of Section 3 of Wade Hampton Gardens, recorded in Plat Book YY at Page 179, and described as follows:

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

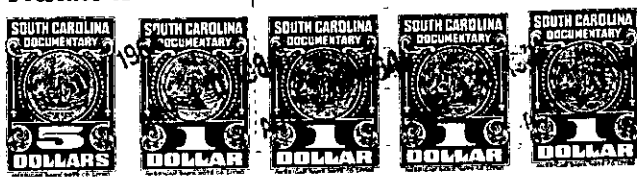
