A Corporation chartered under the laws of the State of South Carolina, in consideration of **Seven Thousand Five Hundred and no/100** -----

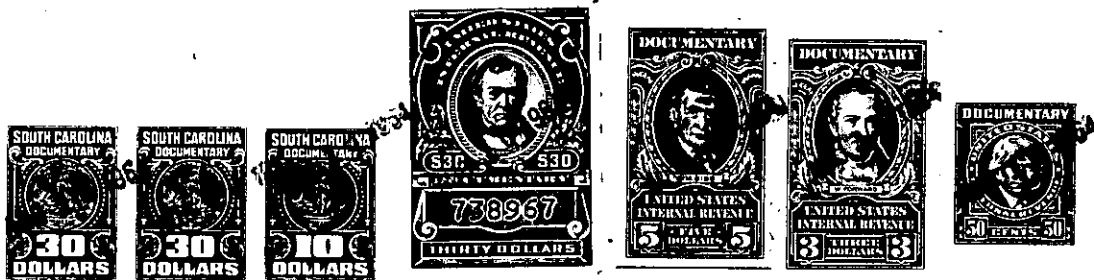
and exchange of property valued at **Twenty-Seven Thousand Five Hundred**-----Dollars, the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto **G. J. HUGHES, his Heirs and Assigns:**

ALL that lot of land in Greenville County, South Carolina known and designated as Lot Number Thirty-One (31) of Section One (1) of Chanticleer, Inc. as shown by a plat thereof made by R. K. Campbell, dated September 29, 1962, and recorded in the R.M.C. Office for Greenville County in Plat Book YY at page 97; and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the southwestern side of Chanticleer Drive at the joint front corner of Lots 30 and 31 and running thence with the southwestern side of Chanticleer Drive the following courses and distances: S. 89 - 46 E., 26.8 feet, S. 80 - 54 E., 50 feet, S. 62 - 45 E., 50 feet, S. 43 - 21 E., 57.5 feet, and S. 32 - 54 E., 30 feet to a pin at the joint front corner of Lots 31 and 32; thence with Lot 32, S. 56 - 25 W., 171.7 feet to a pin in the line of Lot 34; thence with Lot 34, N. 49 - 55 W., 40 feet to a pin at the rear corner of Lot 30; thence with Lot 30, N. 0 - 59 W., 167.3 feet to the beginning corner.

This property is subject to easements and restrictions shown on said plat and to restrictive covenants recorded in the R.M.C. Office for Greenville County in Vol. 713 at page 221 and Vol. 716 at page 321.
