KNOW ALL MEN BY THESE PRESENTS, that W. E. SHAW, INC.

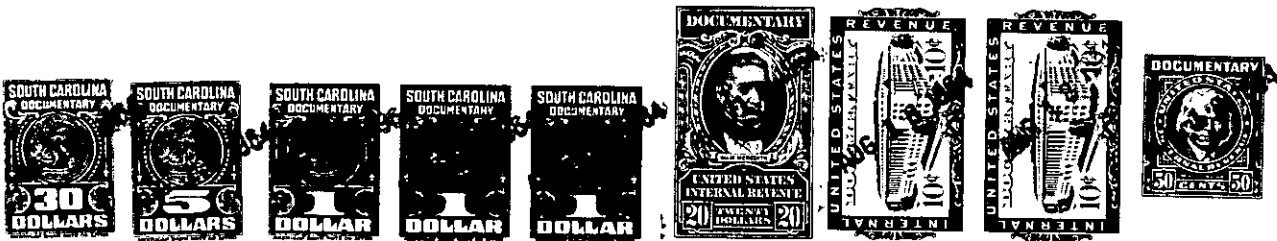
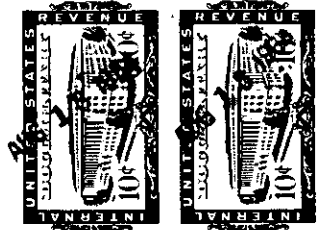
A Corporation chartered under the laws of the State of SOUTH CAROLINA and having a principal place of business at GREENVILLE State of SOUTH CAROLINA, in consideration of EIGHTEEN THOUSAND NINE-HUNDRED FIFTY AND NO/100 ----- (\$18,950.00) --- Dollars,

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto William J. Norman and Marsha F. Norman, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot #101, of a subdivision known as Homestead Acres, Section 11, as shown on a plat prepared by Piedmont Engineering Service, dated April 26, 1963, and recorded in the R.M.C. Office for Greenville County in Plat Book XX, at Page 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Havenhurst Drive, joint front corner lots #101 and #100, running thence along the joint line of these lots, N. 6-33W. 172.0 feet to an iron pin in the line of lot #99; thence along the line of lot #99, S. 87-50 W. 90.0 feet to an iron pin on the eastern side of Cateham Way; thence along the eastern side of Cateham Way S. 2-10 E. 157.3 feet to an iron pin at an intersection, which intersection is curved, the chord of which is S. 50-09 E. 33.5 feet to an iron pin on the northern side of Havenhurst Drive; thence along the northern side of Havenhurst Drive, N. 81-53 E. 78.5 feet to an iron pin, point of beginning.
