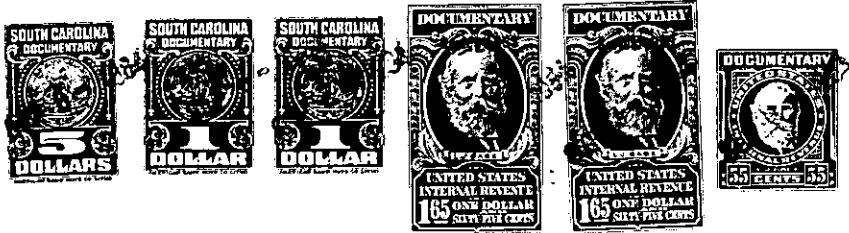
in consideration of Thirty Four Hundred Sixty Three and 50/100 (\$3463.50)----- Dollars,
