KNOW ALL MEN BY THESE PRESENTS, that we, Robert William Holcombe and Nelle Pauline D. Holcombe

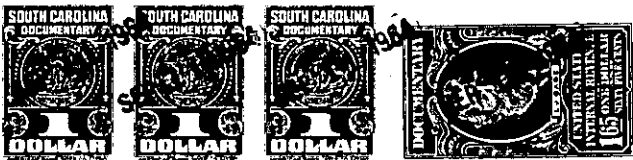
in consideration of Eleven hundred and no/100----- Dollars,

All that piece, parcel, or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina being known and designated as Lot 29 on plat of Dukeland Park, which plat is recorded in the RMC Office for Greenville County in Plat Book J, pages 220 and 221, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northern side of McMakin Drive, at the front corner of Lot 30, which pin is 323.4 feet east of the intersection of said Dukeland Drive; thence with the line of Lot 30, N. 8-28 E. 150 feet to an iron pin on the line of Lot 34; thence with the line of said lot S. 81-32 E. 50 feet to an iron pin, rear corner of Lot 28; thence with the line of said Lot S. 8-28 W. 150 feet to an iron pin on the Northern side of McMakin Drive; thence with the Northern side of said Drive, N. 81-32 W. 50 feet to the beginning.
