Know All Men by These Presents:

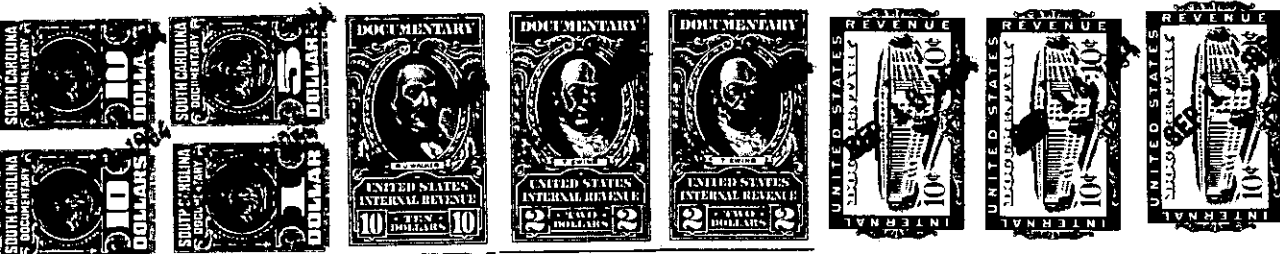

Charles R. Ballew, his heirs and assigns, forever:

All that piece, parcel or lot of land, with buildings and improvements thereon, situate, lying and being in Greenville County, South Carolina and being shown as Lot No. 84 on a plat of Farmington Acres, recorded in the RMC Office for Greenville County in Plat Book RR, Pages 106-7 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Shubuta Drive at the joint front corner of Lots 84 & 85 and running thence with the common line of said lots S. 37-15 E. 150 feet to an iron pin; thence S. 52-45 W. 90 feet to an iron pin; thence N. 37-15 W. 150 feet to an iron pin on the southerly side of Shubuta Drive; thence with said Drive N. 52-45 E. 90 feet to the point of beginning.
