ALL that parcel of land in the County of Greenville, S. C. near Grove and Faris Roads containing 7.75 acres, more or less, and shown on a plat entitled "Earle Property and Hughes Property" made by R. K. Campbell, Surveyor, dated August, 1964 and recorded in the Greenville County R.M.C. Office in Plat Book YY, at page 196, and having, according to said plat, the following metes and bounds:

BEGINNING at a pin at a creek 102.2 feet, more or less, from the intersection of said creek with the right of way of Grove Road (which pin is at the corner of 0.33 acre tract being conveyed by Grace F. Earle to R. E.
