(the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, DO
GRANT, bargain, sell and release unto the said Harvey Robinson a certain piece

or parcel of land in the County and State aforesaid on the East
side of Jones Gap Road and on branch waters of the Middle fork
of Saluda River, being part of the John Bates tract bearing the
