KNOW ALL MEN BY THESE PRESENTS, that

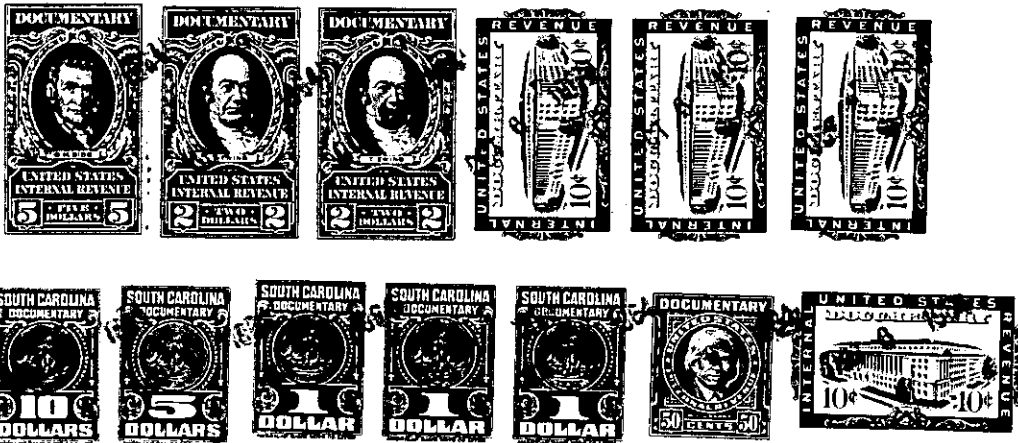
in consideration of EIGHT THOUSAND SEVEN HUNDRED FIFTY AND NO/100 (\$8,750.00) Dollars,

All that lot of land in the County of Greenville, State of South Carolina, near the town of Greer lying on the eastern side of S. C. Highway 14 and being known as Lots 19 and 20 on a plat of the property of B. W. Waters recorded in plat book U at page 150; said lots being described as a whole having the following metes and bounds to-wit:
