to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Apostolic Faith Church of Greenville, S. C., its successors and assigns forever:

All those certain pieces, parcels or lots of land in Greenville Township, Greenville County, State of South Carolina being known and designated as Lot No. 2 and Lot No. 3 on a plat of Mrs. R. J. Bryson property, recorded in Plat Book R at Page 149 and having the following metes and bounds, to-wit:

BEGINNING at a point on the south side of State Highway No. 13, joint corner of Lot Nos. 1 and 2, and running thence with line of said lots, S. 9-45 E. 397 feet to joint corner of said lots; thence S. 80-45 E. 130 feet to joint corner of Lots 3 and 4; thence with line of lots 3 and 4, N. 5-50 W. 430 feet to joint corner of said lots and thence with said Highway No. 13, S. 84-45 W. 130 feet to the beginning corner.

The Grantor also hereby conveys to the Grantee all his right, title and interest in and to all that certain strip of land at the rear of and adjacent to said lots 2 and 3 and being 130 feet long and 25 feet wide.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

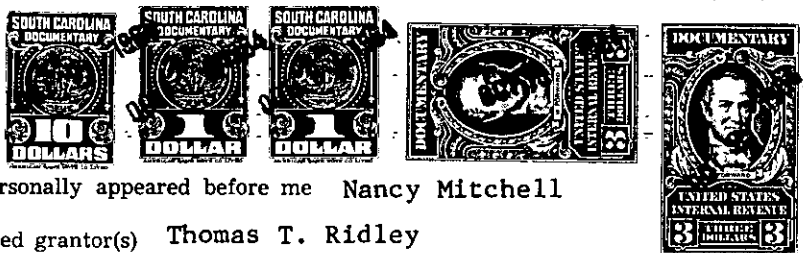
TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and its successors and Assigns forever.
