in the State aforesaid, in consideration of the sum of Three Thousand and no/100 - - - - (\$3,000.00) - - - DOLLARS,

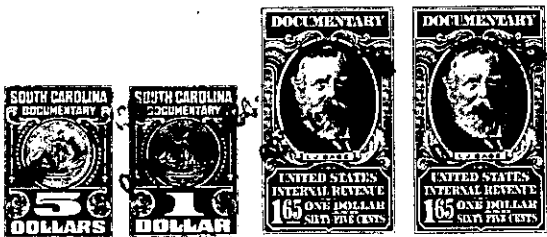
