in consideration of the sum of (\$13,600.00) to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

MELVIN W. HARPER and SHIRLEY HARPER, their heirs and assigns forever:

ALL that lot of land with the buildings and improvements thereon situate on the Southeast side of Shubuta Drive near the City of Greenville in Greenville County South Carolina, being shown as Lot No. 89 on plat of Farmington Acres, made by Carolina Engineering and Surveying Company, December, 1962, recorded in the R.M.C. Office for Greenville County, S. C., in Plat Book RR, Page 107, and having, according to said plat, the following metes and bounds, to wit:
